Our priority is to give children and youth a voice in a system (child protection) that often talks about them without engaging them in decisions about their care.

CLC represents children and youth ages 10-21 in Hennepin and Ramsey counties. By mobilizing over 320 volunteer attorneys CLC provides legal representation to 800 children per year. We make sure these kids have a voice!

The following stories demonstrate the many areas of these children's lives that are impacted by CLC staff and volunteer legal representation and advocacy. Thank you for your generous commitment.

SUCCESS HIGHLIGHTS:



Flexible client visits: some clients met weekly (by ZOOM) with their attorneys, something that was not possible before the pandemic.



Hennepin County Adoption Day Return: four CLC clients were officially adopted and there were several other adoptions hearings before the holidays. This was great news as it provided stability to the kids that most needed it.



CLC saw an encouraging number of high school graduates in 2021, especially considering the challenges the COVID-19 pandemic caused in the area of education. A number of clients also reported doing well with the transition back to in person learning during spring, and the flexibility of school learning modes has been a welcome change.

RAMSEY COUNTY ANNOUNCEMENT

Due to CLC advocacy, Ramsey County Juvenile Justice partners are now holding Zoom hearings for re-entering Extended Foster Care (EFC) youth. This is good news!



Legal Advocacy:

CLC advocated to instate ZOOM hearings for 18-21-year-olds re-entering extended foster care. This was good news! Anne Gueinzius, CLC managing attorney shared, "It is important for all parties to put eyes on the youth when they are making decisions about the young person's future."


SUCCESS STORIES, CONTINUED!

CURRENT CHALLENGES

CLC found remote legal work to be a much higher level of work in the context of the courtroom and the office. CLC fundraised for remote technology for staff this year, needing to purchase laptops, monitors, and docking stations to conduct most work from home.

Impact of COVID-19 in 2021:

Overall, CLC had less access to kids in 2021. Social Workers were often kept from meeting kids in-person due to COVID, which is not the same.

Remote school had varying success rates for most kids. In recent conversations with new clients, many of them have said that they are excited to get to in person learning. Some have already returned to school and others are returning soon. They say "online learning was fine but I missed being with my friends". Unfortunately, we are seeing an increase in cases as children return to in-person school, many of whom are children who are reentering child protection.


