

## **About Give to the Max Day**

Give to the Max Day began in 2009 to launch GiveMN, a collaborative venture led by Minnesota Community Foundation and other partners committed to strengthening our state. That first spark inspired an outpouring of generosity—\$14 million in just 24 hours. Since then, Give to the Max has become Minnesota's annual giving holiday, raising more than \$250 million in its first 13 years. Each year, thousands of organizations and individuals generate donations and excitement for causes that improve the quality of life for all Minnesotans.

"Give to the Max is a celebration of Minnesotan generosity and the impact it has in every community across our state," said Jake Blumberg, executive director of GiveMN. "Every year, we start at \$0 and are humbled by the power hundreds of thousands of gifts can have when our community gives together during Minnesota's giving holiday."

#### Why Give To CLC?

Every day, hundreds of children in Minnesota's foster care system face instability, moving from home to home and struggling with trauma, neglect, and feelings of abandonment. Many of these youth grapple with overwhelming challenges—such as mental health struggles, social isolation, or the stigma of being in foster care—while navigating a complex legal system that often overlooks their voices.

It is urgently important to address this challenge because no child should feel invisible in decisions about their own life. Without legal advocacy, foster youth risk being left without access to critical services, facing prolonged uncertainty about where they will live, or being separated from supportive family connections. With representation and support, however, children are far more likely to experience stability, emotional well-being, and hope for the future.

#### **How CLC Meets This Need**

That's where Children's Law Center of Minnesota comes in. Our staff attorneys and more than 200 trained volunteer attorneys provide free legal representation to youth ages 10–21 in foster care. We amplify their voices in court, fight for their rights, and connect them with resources they need to succeed. With CLC by their side, young people gain not only a legal advocate but also a sense of belonging and stability during an uncertain time.

#### What We Need & How You Can Help


To continue meeting the rising demand for our services, CLC depends on community support. Your donations on Give to the Max Day directly fund training for volunteer attorneys, court representation for children, and critical support services that help foster youth thrive.

- \$100 helps tacilitate critical introductions for a child
- \$250 can provide months of legal representation for a child
- \$500 can help expand training for dedicated volunteers
- \$1,000 can provide a year of legal representation for a child



### Children's Law Center of Minnesota By The Numbers

Between July and September 2025 CLC provided legal representation to 311 Minnesota youth in foster care (new and continued representation). Of these youth, 49.8% (155) are female, 50.2% (156) are male; 66.6% (207) of the cases are within Ramsey County, 33.1% (103) are in Hennepin County, and one case is currently open in Washington County (.3%).
