Because 18 Doesn't Mean Ready

Upon turning 18, a CLC client faced a request from the county to terminate his foster care jurisdiction, which would have prevented him from receiving Extended Foster Care benefits and ongoing support. After spending most of his life in restrictive residential placements, he had only recently transitioned to a community-based group home.

The county proposed transferring him to adult mental health services, even though he was still waiting to be assigned a case manager, did not have his vital documents, and had not yet received many of the services needed to support a successful transition to adulthood.

CLC successfully advocated for the youth to remain in foster care. The court ultimately ruled that the county must continue jurisdiction and provide additional services to ensure he has the support needed to transition safely and successfully into adulthood.

Children's Law Center of Minnesota (CLC) was founded in 1995 to ensure that children and youth in the child protection system have a voice and a dedicated advocate standing beside them in court. CLC provides direct legal representation to youth, primarily those involved in the foster care and child welfare systems, and works to improve the broader systems that impact their lives.

Since its founding, CLC has trained more than 1,000 volunteer attorneys and served over 4,000 children and youth who have experienced abuse, neglect, and instability. Through both individual representation and systemic advocacy, CLC works to ensure that young people are heard, their rights are protected, and they have the support they need to move toward safe, stable, and successful futures.

CLC was created through the collaborative efforts of attorneys, judges, social workers, educators, medical professionals, and child advocates who recognized that children in the foster care system needed stronger, more effective legal advocacy. Today, that mission continues — ensuring that every child we serve has a voice, a choice, and someone fighting for their best possible future.
